signing an ACAA – an Agreement on Conformity Assessment and Acceptance of Industrial Products – between Ukraine and the EU, also called an “industrial visa-free regime”, has been identified as a top priority by the government of Ukraine and as a next step in relations between the EU and Ukraine.

As work on the topic is ongoing, there remains a need for information and some open questions by both companies and policymakers:

- Who and what goods would be covered by the EU-Ukraine ACAA?
- When is a signing realistic and what work must be completed before?
